Applicant shall, upon demand by Township, provide an insurance certificate naming the Township as an insured party with coverage at levels satisfactory to the Township. The certificate required hereunder shall evidence that no less than a fifteen (15) day written notice will be given to the Township prior to the cancellation of the policy. The use of Township property, consistent with the permit granted by the Township, shall be restricted to the purposes for which the property has been permitted to supervise the use of the Township buildings or property in order to enforce the Applicant's breach of Township rules and regulations or to revoke the permit in the event of the Applicant's breach of Township rules and regulations. The applicant has read Township Ordinance #152 and a copy of the Township Park Rules & Regulations and is familiar with the terms thereof and acknowledges Applicant's responsibility thereunder. Applicant agrees further to abide by any special instructions issued by the Township to Applicant with respect to the use and operation for the above purpose.

## RULES & REGULATIONS

1. Park users must abide by all signs.
2. No alcohol or illegal substances allowed in the park at any time.
3. No littering or dumping.
4. No glass bottles.
5. No pets or livestock.
6. No motorized vehicles including ATV's permitted beyond the parking lot.
7. No skateboarding or roller skating.
8. No defacing or damaging property.
9. No wading, swimming, or ice skating.
10. No hunting or shooting.
11. No camping, archery, golfing, or horseback riding.
12. No disturbing wildlife or vegetation.
13. No excessive noise or indecent language.
14. No lanterns, stoves, heaters, etc. Fires permitted only in Township provided grills for the purpose of cooking food.
15. No trespassing onto Township property that is not open to the public.
16. Permits or permission is required for pavilion reservation, parade, ceremony, musical, theatrical, or other entertainment. Any event which would include mechanical or animal rides, bonfires, or create a danger or risk because of the nature of the activity. Public meeting or gathering of twenty-five (25) or more people.

These rules and regulations are made pursuant to the provisions of the **East Vincent Township Ordinance #152** as adopted August 16, 2000. Violation of any such rule shall subject the offender to those penalties as set forth in the said Ordinance Section 5.17, "Penalties and Fines for Violation". These rules and regulations reflect a portion of the Ordinance of the East Vincent Township Parks and Recreation Department.
